(c) Club Metro 2020 Financial Request

(Originating Sources: Charlie Rosol, Club Metro President/Becky Eicher, Club Metro Treasurer)

Background

Club Metro, the non-profit employee club for Cleveland Metroparks, wishes to extend appreciation to the Board of Park Commissioners for its financial support of \$6,500 in 2019. With this financial support, Club Metro helped support employee activities during 2019 through networking/social events (employee picnic, year-end event, etc.), charitable events (Cleveland Food Bank, etc.), and support of Charity Choice. Club Metro's 2020 membership at this time includes 190 Cleveland Metroparks employees and retirees.

In 2019, Club Metro earned \$7,047.96 from membership dues (at \$35.10/employee). A 2019 audit, conducted by James G. Zupka, CPA, Inc., is on file with Club Metro President Charlie Rosol, Treasurer Becky Eicher and Cleveland Metroparks Chief Financial Officer Bill Chorba, with no irregularities reported. As of December 31, 2019, the current treasury balance is \$13,370.94 (catering invoice from holiday party in the sum of \$4,356.50 did not clear until early January 2020 and PCI Entertainment was not hired for casino night in the sum of \$3,000 as guests enjoyed Wild Winter Lights at the Zoo instead).

Activities planned for 2020 may include, but not limited to: volunteer work at the Greater Cleveland Food Bank, tree planting, summer picnic, after work gatherings, holiday event, and more. Members are given weekly discounts to over 100 various companies through membership in the Best Benefits Club (BBC).

<u>No. 20-02-023</u>: It was moved by Vice President Moore, seconded by Vice President Berry and carried, to authorize payment of \$6,500 to Club Metro for 2020, with Club Metro's pledge to match the funding of \$6,500 through membership dues and fees.

(d) Resolution Accepting Ohio Department of Natural Resources Boating Safety Education Grant

(Originating Sources: Joseph V. Roszak, Chief Operating Officer/Mary Rouse, Director of Outdoor Experiences/Rachel Nagle, Outdoor Recreation Manager)

Cleveland Metroparks will receive \$24,513.70 from the Ohio Department of Natural Resources Boating Safety Education Grant program to support Outdoor Recreation programs. The grant funds will be used to purchase fully adapted kayaks and adaptive equipment demonstrating Cleveland Metroparks commitment to the Americans with Disabilities Act (ADA) and the Core Values of Respect and Dignity for all. Funds will also be used to replace a fleet of entry level kayaks, paddles, and supplemental equipment. This equipment will be used for kayaking instruction to create opportunities for a wide range of individuals promoting safe and fun recreation. Cleveland Metroparks cost share for the grant is \$9,067.84 to be paid as in-kind salaries for existing program staff.

It is required by the Ohio Department of Natural Resources to provide for proof of agency commitment through a resolution authorizing the political subdivision to enter into an agreement with the Ohio Department of Natural Resources for the grant program.

(e) Euclid Creek Reservation: Authorization to Submit Grant Application and Commit Funds

(Originating Sources: Natalie Ronayne, Chief Development Officer/Jim Rodstrom, Director of Construction/Kristen Trolio, Grants Manager)

The Recreational Trails Program (RTP) is a cooperation between the Ohio Department of Natural Resources and the Federal Highway Administration to fund trail projects in the State of Ohio. Eligible projects under RTP include the construction of connector and loop trails and trailheads, as well as maintenance and repairs to existing trails. Cleveland Metroparks received funds from this program in 2018 for the construction of the Engle Road Connector Trail in Big Creek Reservation.

Cleveland Metroparks plans to submit an application to the RTP for construction of a portion of the Euclid Creek Reservation Eastern Connector Trail, which will connect the K. Hovnanian property in the City of Richmond Heights (acquired in 2018) to the existing Welsh Woods Picnic Area in Euclid Creek Reservation. This application will focus on a 3,300 lineal foot all-purpose, ADA-accessible loop trail, which will lead to an overlook deck situated atop the ridgeline on the K. Hovnanian property, which offers picturesque views of the river valley.

This paved loop trail will then connect to a 2,000 lineal foot aggregate hiking trail that follows the ridgeline down to a pedestrian cable suspension bridge that will span Euclid Creek and connect to the existing Welsh Woods Picnic Area and to the existing trail network in the reservation. This pedestrian bridge has been funded through an individual donation. This project in its entirety will be transformative for Euclid Creek Reservation. A map of the proposed Euclid Creek Reservation Easter Connector Trail is on page **90951**.

required to satisfactorily complete the proposed project and become eligible for reimbursement under the terms and conditions of the program; and further, that the Board authorize the Chief Executive Officer to enter into an agreement and execute any other documents as may be required to accept the grants upon award; form of document(s) to be approved by Chief Legal and Ethics Officer.

(f) Lakefront Reservation: Authorization to Submit Grant Application and Commit Funds (Originating Sources: Sean E. McDermott, Chief Planning and Design Officer/Natalie Ronayne, Chief Development Officer/Mary Rouse, Director of Outdoor Experiences/John Cardwell, Architect/Kelly Coffman, Senior Park Planner/Kristen Trolio, Grants Manager)

The Ohio Department of Natural Resources Division of Parks and Watercraft has launched a new grant program, the Paddling Enhancement Grant program, to fund waterway access for hand-powered watercraft at public facilities throughout the State of Ohio. Cleveland Metroparks plans to submit an application to this program for a new public access point at East 55th Street Marina, which will include an ADA-compliant floating launch and necessary site preparation.

The "Lake Erie Water Trail - Cuyahoga County" has received preliminary approval from Ohio Department of Natural Resources as a state-designated water trail. The water trail is envisioned as part of an eventual statewide Lake Erie Water Trail. Cleveland Metroparks currently offers access points to Lake Erie for paddlers at Huntington Beach, Edgewater Park, Wendy Park, Gordon Park, and Wildwood Park. The Park District has coordinated with the county's seven lakefront communities and other public agencies to improve access to the lake and create the water trail.

This proposed project at East 55th Street Marina would provide paddle access within both the Federal Breakwall and the additional shelter of the East 55th Street Marina breakwall. The East 55th Street embayment is currently proposed as a water trail rest area, however there is no landing zone since the water's edge is lined with large, irregular boulders; this project will create a landing zone. This new access point at East 55th Street Marina will include a floating dock that meets ADA requirements. The dock will connect to nearby parking areas via an accessible path. This will be the first ADA-compliant access point offered along Lake Erie in Cuyahoga County.

No. 20-02-026: It was moved by Vice President Moore, seconded by Vice President Berry and carried, to authorize the Chief Executive Officer to approve the adoption of the resolution to authorize the submittal of a grant application to the Ohio Department of Natural Resources for funding assistance of \pm \$75,000 through the Paddling Enhancement Grant program as described above; to authorize and agree to obligate matching funds of \pm \$9,200 and all the funds required to satisfactorily complete the proposed project and become eligible for reimbursement under the terms and conditions of the program; and further, that the Board authorize the Chief Executive Officer to enter into an agreement and execute any other documents as may be required to accept the grants upon award; form of document(s) to be approved by Chief Legal and Ethics Officer.

(g) Brookside Reservation: Authorization to Enter into Grant Agreement and Commit Funds

(Originating Sources: Natalie Ronayne, Chief Development Officer/Jim Rodstrom, Director of Construction/Jennifer Grieser, Director of Natural Resources/Kristen Trolio, Grants Manager)

Cleveland Metroparks has received a grant award of \$137,500 from the National Fish and Wildlife Foundation's Sustain Our Great Lakes program to add green infrastructure elements to the parking area adjacent to the Brookside Valley Event Site in Brookside Reservation. A map is on page **90954**. This parking area is ~3.2 acres with 3.99 acres of contributing drainage area and is located immediately adjacent to Big Creek, a primary tributary to the Cuyahoga River. Stormwater from the surface of the parking lot drains via sheet flow to the southeast corner of the lot and discharges via storm drains into Big Creek. The runoff carries salt and other vehicle residue, such as motor oil and antifreeze, into the creek.

This project will add four vegetated bioretention cells that total 11,310sf to the existing parking area. The concept plan is on page **90955**. These cells will reduce stormwater runoff by 2,504,950 gallons/year and will capture and treat the "first flush" volume of stormwater, which carries the majority of pollutants. As part of this project, Cleveland Metroparks will partner with The Ohio State University to monitor the benefits of the green infrastructure elements on stormwater quantity and quality.

The mission of the Sustain our Great Lakes program is to protect and restore habitat throughout the Great Lakes basin, particularly in areas that have been negatively affected by human activity. Green infrastructure, along with riparian and stream habitat restoration, are priorities of this program. The program is a public-private partnership funded by government agencies, private foundations, and corporations and administered by the National Fish and Wildlife Foundation.

(h) Increase for Rental of Mobile Trailer for Police at Timberlane Farms (Originating Sources: Charlie Rosol, Procurement Manager/Katherine M. Dolan, Chief of Police/Rich Svoboda, Captain/Jessica McNally, Sergeant-Mounted Unit)

On August 24, 2015, Cleveland Metroparks entered into an agreement and secured a Purchase Order (20181211 (previously 20160320 and D07765)) in the amount of \$12,350, which was reported to the Board on the \$10,000-\$50,000 list on September 9, 2015, with Apple Mobile Leasing to rent a mobile trailer as a temporary office for Police (Mounted Unit) staff.

Since that time, several increases have been made to this purchase order through 2019 due installing an aluminum bottom skirting in the sum of \$2,760 in December 2015 and renewing the rental agreement in one (1) year increments from 2016-2019. Cleveland Metroparks staff is currently exploring office area options for Police staff however, until a viable option is secured, Park District staff recommends renting the Mobile Trailer for an additional two (2) years.

In light of this, the Board is hereby asked to approve an increase of \$17,400 to the award amount. Since the original purchase order was for an amount less than \$50,000, under the By-Laws the Board was not required to approve the request. The cross-over to the \$50,000 and above level now requires Board approval for a revised amount as follows:

(i) Award of RFP #6458-b: Beecher's Brook Restoration, North Chagrin Reservation; and Chagrin River Restoration at Jackson Field, South Chagrin Reservation – Design Builder

(Originating Sources, Sean E. McDermott, P.E., Chief Planning and Design Officer, Chris Cheraso, Landscape Architect)

Background

On October 1, 2019 Cleveland Metroparks issued a Request for Qualifications (RFQu) for design-build teams to submit qualifications for the design and implementation of two components; Beecher's Brook Restoration, North Chagrin Reservation ("Beecher's Brook Project") and Chagrin River Restoration at Jackson Field, South Chagrin Reservation ("Jackson Field Project") (collectively referred to as the "Project"). The Project will be awarded to one (1) design-build team.

The Beecher's Brook component will reverse stream impairments and establish a foundation for ecological recovery for this primary headwater of the Chagrin River. Jackson Field, adjacent to the Jackson Field Project, is considered an exceptional example of Chagrin River floodplain and features abundant plant and animal species. The Chagrin River is designated as a State Scenic River; however, excessive erosion along its banks are threatening water quality and restoration is required. Together the two separate restoration components will improve water and habitat quality within the Chagrin River Watershed.

Conceptual designs recommend restoration methods using natural channel design and bioengineering to stabilize eroding streambanks, improve in-stream and floodplain riparian habitat, and reduce sediment and nutrient loads that are polluting high quality water resources downstream of the Project sites. As is allowed under Ohio law, Cleveland Metroparks staff is acting as the criteria architect on the Project.

The Beecher's Brook Project is funded by Ohio Environmental Protection Agency 319 (h) Grant, Water Resource Restoration Sponsor Program, Cleveland Metroparks and the Cleveland Museum of Natural History Trout Club Program. The Jackson Field Project is funded by the Ohio Environmental Protection Agency 319 (h) Grant, Northeast Ohio Regional Sewer District and the Cleveland Metroparks. As a Project partner, Chagrin River Watershed Partners, Inc. will contribute to the Ohio Environmental Protection Agency 319 (h) Grant Education and Outreach deliverables.

The RFQu yielded eight (8) responding design-build teams. The team's statements of qualifications were reviewed by a panel of Cleveland Metroparks staff, including Sean McDermott, Jim Rodstom, Mike Durkalec and Chris Cheraso. Through an independent evaluation of the qualifications, the review panel determined a short list of four (4) teams and requested proposals from each. Proposals were received by three (3) of the four (4) shortlisted firms (Biohabitats retracted their interest) and each team was interviewed. The interview panel

included Sean McDermott, Jenn Grieser, Jim Rodstrom, Mike Durkalec and Chris Cheraso. Laura Bonnell from Chagrin River Watershed Partners, Inc. provided support. Following the interviews, the proposals from each short-listed design-build team were then ranked by the review panel in compliance with the Ohio Revised Code (ORC). As permitted by the ORC, both qualifications and proposed price are blended to produce a "best value" score. At Cleveland Metroparks election, qualifications are weighted at 70% and price at 30%. Below is a listing of the short-listed teams, and their correlating "best value" score.

The price reflected in the above table includes the preconstruction services fee, the due diligence and design fees, the preconstruction expenses, estimated general conditions costs (based on percentage of construction cost), construction stage design fees (based on percentage of construction cost), and the design-builder fee (based on percentage of construction cost). An estimated total Project cost of \$673,730 was provided to the contractors as a common basis of expectation. Once construction documents are nearly complete, Cleveland Metroparks staff will return to the Board to set a Guaranteed Maximum Price, at which time, inclusive of construction costs, the general conditions costs, construction stage design fees, and the design-builder fee will be finalized. Upon the negotiation of a contract with the recommended design-build firm, RiverReach Construction (RiverReach), the preconstruction services fee, due diligence and design fee, and preconstruction expenses will be established at \$127,786.

RFP Analysis

Staff recommends the design-build contract be negotiated and awarded to RiverReach Construction. Over the past 13 years, RiverReach and Enviroscience, Inc. have partnered in over 40 design-build ecological restoration projects, many located in Northeast Ohio. Their longstanding collaboration helps increase project creativity, efficiency, and quality. The team has recently performed projects with several partners to Cleveland Metroparks. Most recently the team has completed restoration along the Euclid Creek Lacustrine at Euclid Creek Reservation for Cuyahoga County Soil and Water Conservation District, West Creek Coventry Stream Restoration at West Creek Reservation for West Creek Conservancy. Furthermore, RiverReach has provided restoration services for the Northeast Ohio Regional Sewer District, Western Reserve Land Conservancy, Chagrin River Watershed Partners, Inc. and Holden Arboretum, among other peer organizations. RiverReach's abilities and approach to the Project were well demonstrated in their qualifications, proposal and interview process. Their project team experience, understanding of the goals, and methodology will prove valuable in the execution of the Project. RiverReach's experience with similar and complimentary projects, along with the competitive price associated with their services, establishes their team as the "best value" when ranked against the other short-listed design/build firms. Notwithstanding, Applied Ecological Services and Nerone & Sons, Inc. teams also submitted thorough proposals.

No. 20-02-029: It was moved by Vice President Moore, seconded by Vice President Berry and carried, to authorize the Chief Executive Officer to enter into a Guaranteed Maximum Price contract with **RiverReach Construction** being ranked as the "best value" for RFP# 6458-b, Beecher's Brook Restoration, North Chagrin Reservation and Chagrin River Restoration at Jackson Field, South Chagrin Reservation, inclusive of \$127,786 for preconstruction services fee, due diligence and preconstruction stage design service fee, and preconstruction stage expenses. In the event that a GMP contract cannot be negotiated with the design-builder, a contract would then be negotiated, per Ohio Revised Code, with the next ranked design-builder, who the Board, in its discretion, has reflected in the minutes as being the next ranked design-builder. (j) Award of RFP #6483: Brighton Park Trail and Site Improvement Project – Brookside Reservation – Construction Manager at Risk

Background

On December 16, 2019, Cleveland Metroparks issued an RFQu for firms to submit qualifications for the construction management (at risk) of the Brighton Park Trail and Site Improvement Project (Project). The Project is being developed in partnership with the Western Reserve Land Conservancy (Western Reserve) and the Old Brooklyn Community Development Corporation, who together have raised approximately \$535,000 to date for the transition of the former Henninger landfill into public open spaces and trails. Cleveland Metroparks will enter into both a Project Development Agreement with Western Reserve and either a lease and management agreement or an assumption of their existing conservation easement over the subject parcel(s). Cleveland Metroparks is performing and providing the project design, oversite, and management.

The RFQu yielded four (4) responding construction manager at risk firms. The firm's statements of qualifications were reviewed by a panel of Cleveland Metroparks staff, including Sean McDermott, Andy Simons, John Cardwell, and David Frey. Additionally, serving in an advisory role was Isaac Robb from Western Reserve. Through an independent evaluation of the qualifications, the review panel determined a short list of

three firms and requested proposals from each. Following receipt of the proposal each shortlisted firm was interviewed. Following the interviews, the proposals from each short-listed construction management firm were then ranked by the panel in compliance with the Ohio Revised Code (ORC). As permitted by the ORC, both the qualifications of the firm and their proposed price are

The price reflected in the above table includes the preconstruction services fee, the preconstruction stage compensation, estimated general conditions costs (based on percentage of construction cost), and the construction manager at risk fee (based on percentage of construction cost). The current estimated construction cost is estimated at \$535,000. Once construction documents are nearing finalization, staff will return to the Board to set a Guaranteed Maximum Price, at which time, inclusive of construction costs, the general conditions costs, and the construction manager fee will be finalized. Upon the negotiation of a contract with the recommended construction manager, F. Buddie Contracting, Ltd., the preconstruction stage compensation will be established at \$3,600.

RFP Analysis

Staff recommends the construction manager at risk contract be negotiated and awarded to **F. Buddie Contracting, Ltd.** ("Buddie"). Buddie, who is based in Cleveland, has been in business since 1956, and has performed positively for Cleveland Metroparks in the past on projects such as the Canal Basin Park Initial Greening and the Wildwood Parking Lot green infrastructure, among others. Buddie's abilities, attention to detail and thoughtful approach to the Project were well demonstrated in their qualifications, proposal and interview process. Their project team and goals align with Metroparks staff. Their understanding of the Project, approach and methodology will prove valuable in the execution of the Project. Buddie's experience with similar and complimentary projects, along with the competitive price associated with their services, establishes their firm as the "best value" when ranked against the other short-listed construction manager (at risk) firms. Notwithstanding, the Nerone and Sons, Inc. and Schirmer Construction, LLC also submitted thorough proposals.

(k) Contract Amendment – 1519: RainForest Dome Replacement – Cleveland Metroparks Zoo – Design Builder – Guaranteed Maximum Price 2

(Originating Sources: Sean E. McDermott, P.E., Chief Planning & Design Officer/Christopher M. Kuhar, Zoo Executive Director/Andy Simons, Project Manager/Christopher Widdowson, Architect)

Background

On July 11, 2019 Cleveland Metroparks issued a Request for Qualifications (RFQu #6436) for design-build teams to submit qualifications for the design and installation of a new ETFE (ethylene tetrafluoroethylene) domed roof structure over the orangutan exhibit of the Cleveland Metroparks Zoo RainForest (Project). As identified in the recently

completed facility assessment, the RainForest Dome is in need of replacement and requires special analysis and engineering considerations. Due to those needs, it was requested that the interested design-build teams include a design-assist partner to execute the ETFE specialty design and fabrication. As is allowed under Ohio law, Cleveland Metroparks staff is acting as the criteria architect on the design-build Project.

On September 18, 2019 the Board awarded a Guaranteed Maximum Price Contract to Regency Construction Services, Inc. ("Regency"), for construction manager (at risk) services for the Project. Regency, as did all other proposers, included Vector Foiltec as their design-assist partner for the ETFE foil and dome superstructure. At the time of the Board's original award, only the preconstruction stage compensation was fixed at \$158,301, which included Vector Foiltec's design-assist fees. Per the contract, a Guaranteed Maximum Price (GMP) for construction is then developed and brought back to the Board for approval.

The first of two Guaranteed Maximum Price amendments (GMP 1) was brought before the Board on December 19, 2019 which included the Vector Foiltec ETFE Dome, sprinkler and vent control engineering, soffit design fees, and skylight analysis fees. GMP 1, in the amount of \$1,915,320.49 allowed for the long lead item of ETFE dome fabrication to commence while the balance of the Project costs, captured herein with Guaranteed Maximum Price 2 (GMP 2), could be solidified.

GMP 2 includes the installation of the domed roof structure, demolition, exhibit netting and additional items listed below.

Construction Schedule

(I) Award of RFQu #6447 – Coastal, Shoreline and Riverfront Professional Design Services – Heritage Park and Rivergate Boat Docks

(Originating Sources: Sean E. McDermott, P.E., Chief Planning and Design Officer/John Cardwell, Sr. Landscape Architect)

Background

On July 22, 2019 Cleveland Metroparks issued a Request for Qualifications (RFQu #6447) for a five (5) year term (2020-2024) for professional design services related to twenty-seven types of potential coastal, shoreline and riverfront improvement projects. RFQu #6447 yielded eight (8) responses from consultant teams. Qualifications were

reviewed by Cleveland Metroparks staff and interviews were held with three (3) of the eight (8) consultant teams and, pursuant to ORC 153.69, the top three (3) firms were ranked in order of most qualified. Presented as an Information Item at the December 19, 2019 Board meeting, the KS Associates, Inc. team, which includes Foth Infrastructure & Environment, LLC, The Osborn Engineering Co., and TTL Associates (KS Team) was deemed most qualified by Cleveland Metroparks staff. With concurrence of the Board to select the KS Team as the most qualified, individual contracts will be negotiated on a per project basis and brought to the Board per the Cleveland Metroparks By-Laws.

As presented as an Information Item at the January 15, 2020 Board meeting, staff shared a planning update regarding a proposal to add boat docks to Heritage and Rivergate parks. During the summer of 2019 Cleveland Metroparks was notified of receiving a second recent award of an impactful Boating Infrastructure Grant (BIG). The BIG is administered through the Ohio Department of Natural Resources Division of Parks and Watercraft. The program provides funds for both public and private agencies and marinas to provide transient docks for non-trailerable (greater than 26 feet in length) recreational boats. These federal funds are generated through the The Sport Fishing and Boating Safety Act and grant agreements are made with the U.S. Fish and Wildlife Service. BIG is open to all navigable waters and coastal communities throughout the U.S.

Cleveland Metroparks applied for and received two federal awards through BIG to construct new, transient docks for recreational boaters at both Heritage Park (12 slips) and Rivergate Park (6 slips).

The BIG award provides \$1,146,314 and \$482,770 for the Heritage Park and Rivergate Docks, respectively. Cleveland Metroparks match amounts is \$402,759 and \$169,622, respectively.

Proposal Analysis

A proposal was requested from the KS Team to cover the due diligence and preliminary engineering for the Heritage Park and Rivergate Boat Docks. The proposed cost of \$124,500 covers the below scope:

It is anticipated that the KS Team will need approximately fourteen (14) months to complete the above scope. Furthermore, it is expected that staff will bring forward to the Board a recommended construction manager (at risk) during development of the drawings.

(m) Professional Services Agreement Amendment No 1, Contract 1422 –Hinckley Lake Dam Modifications – Final Design

Background

Cleveland Metroparks is party to a Professional Services Agreement with Michael Baker International, Inc. ("Baker"). In May of 2017, Cleveland Metroparks issued Request for Qualifications No. 6271 ("RFQu") for qualified engineering professionals to study and design modifications to the Hinkley Lake Dam (Hinckley Dam) spillway and adjacent earthen embankments. Six (6) firms responded to the RFQu and following a review by a panel of Cleveland Metroparks staff, the top three (3) firms were ranked in order of most qualified. On August 17, 2017, the Board authorized a professional services agreement

with Baker to complete a preliminary design report in accordance with their proposal dated August 4, 2017 in the amount of \$226,313. At the same Board meeting of August 17, 2017, the Board authorized the preconstruction services phase of a Guaranteed Maximum Price contract with The Great Lakes Construction Company (Great Lakes), the construction manager (at risk). As of March of 2018, Baker had completed the preliminary design report and Great Lakes had prepared the corresponding cost estimates relative to the developed engineering scenarios.

With the preliminary design report completed by Baker and estimates prepared by Great Lakes, a preferred design alternative has been selected. A proposal was requested from Baker to provide the next phase of services for rehabilitation of Hinckley Dam which consist of the phased preparation of construction documents in conjunction with Great Lakes.

Amendment No. 1

The scope of Amendment No. 1 consists of permitting, final design, and meetings and coordination. Included within those tasks Baker will perform wetland delineation and muscle surveys (not relocation), Section 106 preparation, Emergency Action Plan updates, and final hydrology calculations and reports. Plans preparation, which will include lake bottom dredging, will pause at 50%, 75%, and 100% to allow for Great Lakes to review plans for constructability, perform cost estimates, and ultimately prepare a Guaranteed Maximum Price. The current Baker proposal, dated January 31, 2020 for the above-mentioned tasks, proposes an amount not-to-exceed \$368,394. Not requested for authorization at this time is construction administration services by Baker, which is estimated at approximately \$240,000, and which shall be requested of the Board for authorization at the time of construction commencement.

Upon authorization, Baker will commence design and permitting, with an expected design completion in Spring of 2021. A timeline for construction commencement for the Hinckley Dam rehabilitation, which will likely include dredging of Hinckley Lake, is in development.

Background

The City of Fairview Park and Cleveland Metroparks share a mutual concern to provide a safe and secure environment throughout the City and the Park District. Ohio Revised Code §1545.131 provides authority for a park district to enter into agreements with municipal corporations to assist with police protection. The interagency agreement will delineate requests for assistance, Cleveland Metroparks responsibilities, the City of Fairview Park responsibilities and other relevant terms.

(o) Authorization of Land Acquisition: Galland Property, South Chagrin Reservation (±5 acres)

Cleveland Metroparks has the opportunity to acquire a \pm 5-acre property located north of Chagrin River Road and west of Franklin Road in the City of Solon and adjacent to South Chagrin Reservation (reference map, page **90956**). The Galland Property borders the recently acquired Jackson Property, a 73.4-acre property which includes Category 3 wetlands, a Class III primary headwater stream that flows to the Aurora Branch of the Chagrin River, and upland habitat that serves as a buffer for these important aquatic resources. A significant portion of the Galland Property is wetland and connects to the large wetland complex on the Jackson Property. The wetlands support a nice assemblage of native plants. The Galland Property also contains a mature mesic forest on the north side of the property.

Cleveland Metroparks has been in contact with William Galland since August of 2018. Mr. Galland reached out to Cleveland Metroparks regarding selling his property and following the acquisition of the Jackson Property in December of 2019 the Galland Property is now located adjacent to South Chagrin Reservation. This acquisition conserves the wetlands, streams and associated habitat of the Chagrin River watershed and provides additional resource protection and a buffer to the larger wetland complex.

(p) Asian Lantern Festival Agreement: Asian Lantern Festival at Cleveland Metroparks Zoo

Background

Cleveland Metroparks seeks to enter into a new agreement with Tianyu Arts & Culture, Inc. ("Tianyu") for a three-year extension of the Asian Lantern Festival ("Festival") in response to the highly successful and well-attended Festival held in the summer of 2019. In its first year, the Asian Lantern Festival set domestic and international attendance records of 150,000 guests. In its second year, the Asian Lantern Festival set another domestic attendance record of 183,192 guests. This year's Festival will also be a separately ticketed event. Similar to last year's Festival, the 2020 event will occur in the evenings after standard zoo operating hours for a minimum of 28 nights from June to September, Thursday through Sundays. The Festival will feature cultural attractions and animal exhibits during the daylight hours and transition to an illuminated lantern show as the event progresses. Both parties will mutually agree on the event dates for the 2021 and 2022 Festival.

After a very successful 2018 and 2019 festival, Tianyu has proven to Cleveland Metroparks that it is capable of designing and installing a high-quality lantern festival. Under its new agreement with Cleveland Metroparks Tianyu will be responsible for the design, fabrication, and installation of a minimum of 42 lantern vignettes throughout the lower portion of the Zoo in locations approved by Cleveland Metroparks staff. Net revenues shall be split between the parties. The revenue split is a split of ticket sales after deductions of total credit card fees, local admission tax, and ticketing fees if any.

Under this agreement, Tianyu will be responsible for the design, shipping, and installation of the lantern vignettes. Tianyu will be responsible for all lantern lighting and will purchase all materials for the lanterns, including preparing electric cables needed for the power supply inside the lanterns. Tianyu will assume all costs associated with providing artists, performers, and retail craft vendors for the Festival, as well as staff to repair the lanterns throughout the run of the Festival. Tianyu will also be responsible for maintaining commercial general liability and auto coverage and obtaining all required visas for its artists and performers from the United States Citizen and Immigration Services. Tianyu will provide a minimum of four performances, four times each night during the Festival that will occur at the Cleveland Metroparks Zoo Amphitheater.

Cleveland Metroparks will be responsible for the operational logistics of the Festival, including ticketing, guest services, and overall site preparation. Cleveland Metroparks will be responsible for energy costs during installation, exhibition, maintenance, and takedown. Cleveland Metroparks will provide boxes, cables, cords, and generators to run power to the lanterns, if necessary. Cleveland Metroparks will also provide supplemental lighting needed for safety of walking paths and a stage with basic sound and lighting for artist performances. Cleveland Metroparks will be responsible for marketing, promotion, and related marketing expenses for the Festival, and will have sole discretion to determine the final marketing plan for the Festival. Cleveland Metroparks also retains the exclusive rights to corporate sponsorship.

BID #6494 SUMMARY: CHALET PARKING LOT IMPROVEMENTS MILL STREAM RUN RESERVATION

(Originating Sources: Joseph V. Roszak, Chief Operating Officer/Jim Rodstrom, Director of Construction)

In June of 2019, Cleveland Metroparks was awarded a \$151,340 grant from the Ohio EPA Nonpoint Source Program (Section 319(h)) for water quality treatment and detention of the stormwater runoff from the parking lot at The Chalet in Mill Stream Run Reservation. The extended detention of the stormwater in the installed features will allow the suspended sediment and pollutants that the stormwater picks up as it runs across the pavement to settle out. In addition, the detention facilities and green infrastructure will provide storage of the stormwater with controlled discharge after rain events. After the stormwater components of the project are complete, all new asphalt pavement will be constructed over the entire parking lot.

This parking lot improvements bid reflects the following scope of work:

- 1. Abandonment of the existing parking lot drainage system, removal of 5 existing catch basins, and removal of approximately 485 lineal feet of surface mounted curbs.
- 2. Intercepting of existing electrical lines at base of light poles and installation of 530 lineal feet of 2" electrical conduit with (5) 12"x24" non-traffic fiberglass handholes.
- 3. Installation of 140 lineal feet of perforated 6" HDPE storm sewer, 315 lineal feet of solid 8" HDPE storm sewer, 189 lineal feet of solid 10" HDPE storm sewer, all associated bends, tees, and caps, #57 stone bedding, and ODOT 304 backfill.
- 4. Installation of 6 new precast 2-3 catch basins and 1 existing catch basin adjusted to grade.
- 5. 2,341 square yards of new full-depth asphalt pavement.
- 6. 3,012 square yards of 1-1/2" grind and 3" overlay of ODOT 448 intermediate and surface course asphalt.
- 7. 2,785 square yards of 1-1/2" 448 surface course asphalt overlay.
- 8. 455 square yards of 1-1/2" transition grinding and 448 surface course asphalt overlay.
- 9. Excavation and bio-soil backfill of 3,630 square feet of bioswales in parking island and adjacent to new full depth asphalt parking pavement.
- 10. Striping of 157 parking stalls, 5 ADA stalls with loading zones, and installation of 157 concrete parking blocks.
- 11. Topsoil, sodding, restoration, seeding, and all other required erosion control measures.

Background

Since 2014 Cleveland Metroparks purchased marine fuel for resale (87 Conventional without lead or ethanol) for East 55th Marina from Great Lakes Petroleum and continued that service in 2016 at Emerald Necklace Marina and Wildwood Marina in 2019.

Great Lakes Petroleum provides a high-quality additive called ValvTect which is an industry leader in fuel additives for marine engines. Boaters recognize that utilization of ValvTect products prevents ethanol/gasoline related problems by keeping moisture in suspension and preventing bacteria and other microbiological growth. This in turn, improves engine performance, reduces fuel consumption and minimizes harmful exhaust emissions.

Research by Cleveland Metroparks staff found an overwhelming majority of Great Lakes boaters prefer to purchase and utilize fuel with the ValvTect additives to keep their engines sound and free from failure. Valvtect's strict regulations for their product causes them to limit their suppliers to be sure that those they authorize can maintain their standards.

ValvTect can only be sold by Certified ValvTect Marine Fuel Distributors that meet strict quality control specifications when adding this product to their 87 Conventional Fuel without lead or ethanol. There are several fuel distributors in Ohio, however Great Lakes Petroleum is the only distributor in the City of Cleveland that holds this certification. Cleveland Metroparks will follow the OPIS (**Oil Price Information Service**) which is the oil industry index used to verify base prices submitted by suppliers and will hold the additive cost per gallon at \pm \$0.04. Other distributors will not hold the additive cost per gallon and do not follow OPIS minimizing real competition for this product.

Recommendation

For 2020, Cleveland Metroparks will continue to self-operate E. 55th Marina located in the Lakefront Reservation, Emerald Necklace Marina located in the Rocky River Reservation and Wildwood Marina in the Euclid Creek Reservation.

Cleveland Metroparks staff recommends continuing the partnership and supply of marine fuel with the ValvTect additive from Great Lakes Petroleum.

<u>RECOMMENDED ACTION</u>:

That the Board authorize the purchase of 87 Conventional Fuel without lead and ethanol that has been treated with ValvTet marine-additive products for Single Source #6495, as noted in the summary above, to be supplied on an as needed basis for the 2020 boating season, from certified distributor **Great Lake Petroleum**, for a **total cost not to exceed \$375,000**, for dispensation/resale at the East 55th, Emerald Necklace and Wildwood Marinas. On July 18, 2019 the Board of Park Commissioners approved the acquisition of a 6.0-acre County Property located at 6100 West Canal Road in Valley View (adjacent to Ohio & Erie Canal Reservation).

In early December 2019, the title of the property transferred to Cleveland Metroparks. Staff has been working diligently renovating the building which will become office and production space for Ohio & Erie Canal Management Operations, Visual Communications, Trails, and Mobile Outreach Divisions along with a designated area for Fleet Management.

A portion of the renovation process includes replacement of all existing carpet and identified areas throughout the building where flooring needs to be replaced.

Cleveland Metroparks will utilize the services by D & R Commercial Flooring in full cooperation with the State of Ohio Contract Numbers 800375, 800483 and 800569; ORC 125.04 for the removal of existing flooring and install new flooring at the new Ohio & Erie Canal Management Center.

D & R Commercial Carpet has successfully completed various flooring projects throughout Cleveland Metroparks (including the Administration Planning and Design Wing, Brecksville Auxiliary Classroom, Sleepy Hollow, Seneca, Manakiki and Shawnee Hills Clubhouses, Police Dispatch Office, Mechanic's Offices, Emerald Necklace Marina and Acacia Storage area).

In early January 2020 an initial contract for Phase I totaling \$14,320.80 (includes demo in the sum of \$5,617.00) with D & R Commercial Carpet was approved for the removal and disposal of all existing broadloom carpet and the supply and installation of replacement carpet squares in the wing of the building that will staff Ohio & Erie Canal Management Operations (under purchase order number 20200326). Phase I was necessary to enable Ohio & Erie Canal Park Operations early entry into the building.

Cleveland Metroparks staff recommends entering into a contract for Phase II of the Project. Phase II will total \$47,597.90 which includes supply and installation of all remaining specified carpet squares (on the South side of the building and in the Visual Communications sign shop area/offices).

Cleveland Metroparks staff also seeks approval for Phase III of the project which will total \$59,924.89 an includes carpet planks, vinyl flooring and tile, and sheet vinyl as identified in various areas throughout the remainder of the building. Staff will contract for and proceed with Phase III onto to the extent funds are available. Thus, the materials outlined under Phase III will be ordered as needed.

a. Chief Executive Officer's Employee Guest(s) (Originating Source: Brian M. Zimmerman, Chief Executive Officer)

David C. Calco, IT Customer Services Supervisor

David Calco's career with Cleveland Metroparks began in June 2019 when he joined the IT Team in the role of Customer Services Supervisor. He brought to his position a multitude of experience that he gained while working as an IT Client Services Manager for Shiloh Industries. While in this position Dave led, trained, mentored, evaluated and directed the North American team of regional support technicians and service desks analysts, including hiring, onboarding, coaching, metrics tracking, and Office 365 training. Prior to working for Shiloh Industries, Dave was employed with Constellation Schools LLC as Technology Director, Cleveland Botanical Garden as Distance Learning Coordinator, Allen Art Musuem as Webmaster, and Ohio e-Tech as NE Regional Faculty. Dave holds a Bachelor's degree in Biology from The Ohio State University.

b. Cleveland Harbor Eastern Embayment Resilience Study (CHEERS) Grant (Originating Sources: Sean E. McDermott, P.E., Chief Planning & Design Officer/Kelly Coffman, Senior Strategic Park Planner)

Cleveland Metroparks is partnering with the City of Cleveland, Ohio Department of Natural Resources, Ohio Department of Transportation, and Port of Cleveland to study issues and opportunities along Lake Erie's shore in eastern Cleveland. The Cleveland Harbor Eastern Embayment Resilience Study (CHEERS) project area extends from Burke Lakefront Airport east to the Cleveland Lakefront Nature Preserve (approximately two miles) and from the existing federal breakwall in Lake Erie south to St. Clair Avenue (approximately one mile).

The study's scope of work includes a general framework plan for the area with a focus on opportunities along the shoreline and into the lake. Local agencies, community organizations, and residents will be engaged throughout the planning process. The plan will explore actions to improve aquatic and terrestrial habitat, protect existing infrastructure, including Interstate 90, and expand neighborhood access and recreational opportunities along the lakefront. The work will propose options for the beneficial re-use of dredge material to help meet project goals.

The five local partners committed at total of \$126,000 to the effort, and the project was awarded a \$125,000 Coastal Resilience grant from the National Fish and Wildlife Foundation (NFWF) in late 2019. CHEERS partners are currently seeking qualifications from consultants; selection and negotiations will conclude in April. A contract will be submitted to the Board for approval at that time. Cleveland Metroparks serves as project manager for the effort.

INFORMATION/BRIEFING ITEMS/POLICY (cont.)

c. Rocky River Reservation Access Study – Old Lorain Road Vicinity

(Originating Sources: Sean E. McDermott, P.E., Chief Planning & Design Officer/Kelly Coffman, Senior Strategic Park Planner)

Bicycle and pedestrian access from neighborhoods adjacent to Cleveland Metroparks Reservations can be challenging due to topography. The Kamm's Corners area of Cleveland is a good example; the neighborhood is separated from Rocky River Reservation below by more than one hundred feet of topographic change. The 2018 Reservation Master Plan identified the lack of bike and pedestrian access to the park in the vicinity of Old Lorain Road on the eastern side of the Rocky River valley. The poor condition of the roadway was also noted as a concern, since it is a key vehicular access point for the park.

Cleveland Metroparks is partnering with the City of Cleveland and West Park - Kamm's Corners Neighborhood Development, the area's community development corporation, to conduct a technical study of potential access options in the vicinity of Old Lorain Road on the eastern side of the valley. The study area is adjacent to Fairview Hospital. The hospital is in the midst of planning a campus expansion. The City of Cleveland is providing the funding for the study (approximately \$50,000).

A consultant will be retained to develop initial concepts. The consultant will provide preliminary concepts and gather public input regarding access options. Preliminary engineering will refine a preferred route and develop a cost estimate for implementation. The study will conclude this summer. Recommendations will be shared with the Board and community partners.


Sustain Our Great Lakes

Cleveland Metroparks Green Infrastructure




