# MINUTES OF THE BOARD OF PARK COMMISSIONERS OF THE

#### CLEVELAND METROPOLITAN PARK DISTRICT

#### **OCTOBER 11, 2013**

The Board of Park Commissioners met on this date, Friday, October 11, 2013, 8:00 a.m., at the Board's office, 4101 Fulton Parkway, Cleveland, Ohio.

The roll call showed President Debra K. Berry, Vice President Bruce G. Rinker, and Vice President Dan T. Moore to be present. It was determined there was a quorum. Chief Executive Officer, Brian M. Zimmerman, Chief Financial Officer, David J. Kuntz, and Chief Legal and Ethics Officer, Rosalina M. Fini, were also in attendance.

#### PUBLIC COMMENTS.

Ms. Marty Lesher of Olmsted Township read from a prepared statement with respect to multiple concerns. Commissioners Moore and Berry took exception to some of the comments made by Ms. Lesher. All of the aforementioned comments can be heard in their entirety by accessing the "About Us" section of Cleveland Metroparks website under "Board Meetings/Board Meeting Archives."

#### **APPROVAL OF MINUTES.**

#### **ACTION ITEMS.**

#### (a) Appointment/Swearing In of Chief Ranger

(Originating Source: Brian M. Zimmerman, Chief Executive Officer)

The creation of the Cleveland Metropolitan Park District Police Department was made possible on June 14, 1920 when the Board of Park Commissioners passed Resolution #315 which called for maintaining "...general peace and order of the park." The first patrolman to be hired was Charles L. Fox. It wasn't until 1947, however, when James Hoy was hired as the department's first chief.

In February 1967 Chief Hoy retired after 39 years of service, and Lou E. Tsipis was named as successor. Walter A. Robb was appointed as the Park District's third chief in February 1973 when Lou Tsipis became Deputy Director of the Park System. Three years later Chief Robb assumed the duties of the Superintendent of Park Operations and James G. Johnson was appointed as successor. Chief Johnson's three year tenure ended when Bourbon L. Zeigler was appointed chief in February 1979.

In the years that followed, not only had many acres of land been added to Cleveland Metroparks, the personnel for the Ranger Department had grown. By the mid-1980's, the Park District's 18,000 acres of land were patrolled by 77 rangers.

In 1988, Chief Zeigler resigned and his successor, Patrick Oliver, was hired from the Ohio Highway Patrol. Oliver served as chief until 1994 when he left to become the Chief of the City of Cleveland's Police Department. James Whitley Jr. from Cleveland Heights Police Department was appointed as the seventh Chief Ranger of Cleveland Metroparks Ranger Department.

Upon Chief Whitley's retirement in 2003, Captain Gregory M. Loftus was promoted and appointed Chief Ranger. The Ranger Department moved into its present headquarters facility in Rocky River Reservation in 2004, with a state-of-the-art dispatch center, prisoner holding facility and forensic laboratory. There is also a ranger museum which displays photographs, uniforms, artifacts and equipment utilized throughout its history. Chief Loftus retired on December 31, 2012.

Captain Dan Veloski was appointed as the Ranger Department's ninth chief. Veloski began his career with the Ranger Department in 1991, starting as a ranger in field operations. He was promoted to sergeant in 1997; lieutenant in 2001; and captain in 2002. He is a member of the Child Abduction Response Team and a Certified Law Enforcement Executive where he has served as a mentor and advisor. Veloski earned a bachelor's degree in criminal justice/political science at Kent State University in 1991, and a master's degree in psychology/diversity management from Cleveland State University in 2005.

Cleveland Metroparks Rangers have a long history of dedication to the Park District and to Northeast Ohio. Chief Veloski is committed to the safety and security of our park visitors, and will continue to move the department forward, as first started by Chief Hoy.

Daniel J. Veloski was administered the Oath of Office by President Debra K. Berry as found on page <u>76624</u>.

#### Walter J. Kendzierski, Ranger Sergeant

Walter J. Kendzierski has served Cleveland Metroparks for 27 years utilizing his knowledge, skills and abilities as a Summer Laborer, Summer Crew Supervisor, Assistant Ranger, Ranger, Senior Ranger, and Ranger Sergeant. Walt was assigned to protect and preserve lands and facilities, ensure visitor safety, and deter violators of the park rules and laws of the State of Ohio. Walt has provided leadership, inspiration and work direction by managing law enforcement staff, providing firearms training, executing safe firing range practices, and designing and implementing an Immediate Action Rapid Deployment Response training program. He has served as a member of the Rope and Water Rescue Team, Youth Gang/Occult Investigation Team, Firearms Training Instructor, Bicycle Patrol Unit, Field Training Officer, and as a Range Coordinator. Walt has also participated with a Presidential visit to the Greater Cleveland area, served as the first team leader for the wildlife management project, was a regional instructor for police mountain bike course, and served with the Fraternal Order of Police, Ohio Labor Council, Inc., the Midwest Gang Investigators Unit and as a member of the Benefit Study Team. Walt's professionalism and dedication has been an asset to the Ranger Department as evidenced by his letters of commendations and awards, namely the Pro Patria Award, and his commitment and hard work have been appreciated by the members of the Ranger Department and will not be forgotten.

(c) Professional Services Agreement – Acacia Reservation Ecological Restoration Plan
(Originating Sources: Richard Kerber, Chief Planning and Design Officer/Terry
Robison, Interim Director of Natural Resources)

#### **Background:**

Milestones in the Acacia reservation:

- October 2012 Cleveland Metroparks accepts the donation of Acacia from The Conservation Fund
- December 2012 Cleveland Metroparks takes title to the 155 acres establishing Acacia as the 17<sup>th</sup> Reservation
- January February 2013 Facility reconnaissance and RFP for the catering facility
- March 2013 Public meetings on a master plan and catering agreement
- April 2013 Staff develops conceptual planning documents and updates the Board
- June 2013 RFQ 5924 is issued for an Ecological Restoration consultant

Of the reservation's 155 acres, it is a goal that the majority either remain in or be restored to a predominantly natural condition. The existing configuration of the property includes two streams, three ponds, wooded areas (roughs), wet areas and a large extent of cleared/mowed areas that comprised the tees, fairways and greens. Determining the suitability of each area for natural area restoration requires expertise in the sciences of evaluating aspects such as soil conditions, hydrologic and hydraulic conditions, storm water management, the arrangement of built facilities to minimize the impacts on natural areas, and of how to design and implement large scale restoration of plant communities.

#### **Consultant Selection:**

Ten firms submitted qualifications in response to RFQ No. 5924. Three firms were short-listed and interviewed. Biohabitats, Inc. was selected as the most qualified firm to provide the ecological consulting services. Biohabitats and their sister company, Ecological Restoration and Management, Inc., are headquartered in Baltimore, Maryland with regional offices in several cities including Cleveland. Biohabitats has a full-time staff of 60 professionals in the fields of Conservation Planning, Ecological Restoration, Regenerative Design and Storm Water Management. Biohabitats lists over 133

Ecological Restoration Projects completed, including several in northeast Ohio. Biohabitats has won recognition for many of their projects including the 2013 John F. Seiberling Award for Regional Cooperation and Resourceful Innovation for the Tinkers Creek Stream Restoration Project and Living Land Lab in Hudson.

#### **Project Scope and Fee:**

In cooperation with Cleveland Metroparks staff, Biohabitats will perform the following tasks:

- Baseline Conditions and Opportunities Assessment
  - o Existing information review
  - o Existing conditions field assessment at Acacia and selected reference sites
  - Technical memorandum documenting conditions and establishing project goals
- Charrette To Refine Restoration Goals and Objectives
  - Conduct a one day charrette with Cleveland Metroparks and project partners to establish final restoration goals
  - o Technical memorandum documenting the charrette
- Restoration Master Plan
  - o Draft master plan
  - o Draft implementation plan
  - o Final master plan and implementation plan
- Work Sessions and Meeting Participation
  - Client reviews
  - o Board and funder presentations
  - o Community meetings/workshops
  - o Partner and stakeholder reviews

Key elements the Master Plan will consider are as follows:

- a) Site-specific restoration strategies and description of the associated requirements to implement these strategies (includes soil restoration requirements, techniques, methods, etc.), including development of an Adaptive Management Framework and integrating it into the Implementation Plan.
- b) Progressive, sustainable and regenerative surface water management at the site and modifications as required/ desired to the existing storm water management ponds, streams, and other flow paths to improve functionality.
- c) Subsurface drainage interventions required to improve sub-surface conditions to support restoration opportunities/ strategies.
- d) Features required to moderate off-site influences/threats to current and future ecological assets including invasive species and storm water runoff.
- e) Options for integrating and converting managed turf areas such as greens, tees, trails, circulation and connections within and adjacent to the site, etc. into the restoration planning, given their drainage and soil features.

#### **ACTION ITEMS** (cont.)

f) Incorporation of desired public improvement, stewardship, research, interpretation and education opportunities to explore the interface of these plans with the Master Plan and assess any modifications needed to achieve the Master Plan's goals and objectives.

g) Identify additional studies and investigations required, which will be the target of additional fundraising by Cleveland Metroparks (stream restoration being a good example).

In their most recent proposal dated September 27, 2013, Biohabitats estimates that the tasks listed above could require up to 927 hours of staff time and travel with a maximum fee not-to-exceed \$120,750. The final fee will be influenced by the number of meetings and the number of Biohabitats staff attending.

The encumbrance was based upon a yearly estimate of office supplies purchased throughout the Park District in a given year. Due to the fact that Cleveland Metroparks previously bought office supplies from more than eleven different suppliers, it was difficult to gauge the yearly spend. By standardizing the procurement of office supplies to one provider through a comprehensive proposal, the Purchasing Division can now track the yearly consumption more accurately. The requested commodity adjustment pays current invoices and anticipates remaining orders through December 31, 2013.

#### No. 12-05-105:

It was moved by Vice President Berry, seconded by Acting President Rinker and carried, to authorize the purchase of various office supplies and services to the following lowest and best proposal for RFP #5801 to **Independence Business Supply (IBS)** to be purchased on an "as needed" basis for a 18-month period, beginning July 1, 2012 through December 31, 2013, **for a total cost not to exceed \$125,000 \$145,000**, with an option to renew for an additional one (1) year period. The renewal is at the sole discretion of Cleveland Metroparks and will be based on overall customer service and unit costs remaining fixed or changed with an approved percentage increase/decrease by Cleveland Metroparks. In the event the log of consumption approaches 90 percent of the estimate, an action item will be presented to the Board requesting an increase. In the event this supplier cannot satisfy the proposal, the award will be given to the next supplier who the Board, in its discretion, has reflected in the minutes as being the next lowest and best proposer who can satisfy the proposal. The difference in cost and all related costs to the difference will be assumed by the original proposer and/or surety.

#### **SOLE SOURCE #5945**: INQUIRY KITS - CONNECTIONS TO AFRICA PROGRAM

for Cleveland Metroparks Zoo Education Division

#### **Background**

Cleveland Metroparks Zoo Education Division, with input from Cleveland Metropolitan School District (CMSD) teachers, wrote the "Connections to Africa" program (Inquiry Kits) to make a connection with CMSD students. The program was designed around scientific inquiry and grade appropriate science standards, as the Ohio Content Standards were about to change. The program is written into CMSD's Scope and Sequence Guide as a requirement for all 5<sup>th</sup> grade classes.

The Inquiry Kits contain books, DVDs, scientific equipment, animal artifacts, developed lesson plans for lower and upper elementary, and much more with the sole purpose of being provided on a loan basis to CMSD. The Education Division's original intent was to give an Inquiry Kit to all 71 CMSD elementary schools.

In 2011, the Zoo Society generously provided adequate funding to Cleveland Metroparks Zoo to purchase 23 Inquiry Kits. Cleveland Metroparks Zoo selected 23 CMSD schools that would receive their own Inquiry Kit based on location and need.

The kits were an immediate success, and many more CMSD schools became interested once they learned about the program. In 2012, the Zoo Society generously provided funding for three (3) more kits specifically for the schools in Slavic Village. These kits were delivered during the spring of 2013. The remaining 45 elementary schools in CMSD have continued to express interest in the Inquiry Kits, and with the funding provided by the Zoo Society, the remaining schools will receive the kits.

#### Recommendation

ECA Educational Services, who is currently under contract with CMSD, provides Science Kit Management and Refurbishment Services and offers materials management services. The partnership between ECA and Cleveland Metroparks Zoo will provide an opportunity to disperse kits to the remaining 45 schools while managing and maintaining the services similar to CMSD.

Cleveland Metroparks Zoo Education Division recommends Cleveland Metroparks Board of Park Commissioners authorize the purchase (Funding Source 5755-67570) of the remaining 45 Inquiry Kits from ECA Educational Services for distribution as noted above.

#### **RECOMMENDED ACTION:**

That the Board authorize the purchase of Sole Source #5945 for 45 Inquiry Kits, as described above, from ECA Educational Services, for a total cost of \$59,930.55.

## REJECTION OF BID #5936: RENOVATION OF THE LAKEFRONT MANAGEMENT OFFICE, LAKE FRONT RESERVATION

#### **Background:**

At the Lakefront Reservation there is an existing 8,000 sf building located at Gordon Park near the Cleveland Lakefront Nature Preserve. The building was constructed by the Ohio Department of Natural Resources (ODNR) and was used as offices and work space for the park management staff and park rangers. The building is divided into four primary use areas: (1) the office wing with approximately 16 offices/work areas; (2) a public space with a large conference room and restrooms; (3) a wing used by ODNR for exhibits and programming; and (4) a basement used for ranger locker rooms.

Staff intends to continue the use of the office wing and locker rooms for Cleveland Metroparks management and ranger staffs and continue the use of the public spaces. The exhibit areas of the building will be repurposed at a later date. A bid package was assembled to make minor modifications to the layout of the office wing, replace worn out lighting and flooring, replace the failing HVAC units, correct basement and roof leaks, and paint the office and public areas.

The design documents for the project were prepared by staff. Bids were solicited for this work with an architect's estimate of \$150,000.

#### **Bids:**

On September 24, 2013, sealed bids were received for the **Renovation of the Lakefront Management Office** and are tabulated as follows:

#### **Bid Analysis:**

As all bids exceeded the estimate by more than 10%, the Ohio Revised Code requires that the bids be rejected. Staff has interviewed the bidders and other contractors who took out plans but did not bid, to determine where the pricing discrepancy occurred. The conclusion was that there was confusion over the scope of work on a roof repair item and the skylight replacement item. Staff has revised or removed those elements which caused the confusion and re-advertised the project for rebid with an estimate of \$165,000.

#### **RECOMMENDED ACTION:**

That the Board reject all bids for Bid No. 5936, the **Renovation of the Lakefront Management Office,** and authorize a rebid.

#### Patrick J. Chambers, Business Analyst – Cleveland Metroparks Zoo

Patrick Chambers recently joined the staff of Cleveland Metroparks Zoo in the position of Business Analyst. Patrick will be working in the Zoological Programs division and with the Curator Team to monitor spending and look for ideas to improve efficiency within the Zoo. He graduated from Baldwin-Wallace with a degree in Accounting, and comes to us from The City of Cleveland Finance Department where he worked for nearly five years. While there, he worked with the Controller to prepare and analyze budgets and assisted in the implementation of many ideas. Both his education and prior experience make him an ideal candidate as we continue to seek ways to improve the Zoo and continue to "create a compelling experience that connects people with wildlife."

#### b. Recognition of Ranger Department Communications Center

(Originating Source: Capt. Jack M. Hall)

The Cleveland Metroparks Ranger Department was created in 1920. At the time, requests for assistance and emergency calls were made through the use of hand-written notes that were left at Ranger notification stations throughout the Park District. By leaving a note and flicking a switch which turned on a red light, passing Rangers would be made aware that someone was in need of help.

This practice continued through the 1950s when the department transitioned to land-based, two-way radio systems. Due to the expansion of the Park District and the Ranger Department, a centralized communications center was created in 1968. Finally, telephone and radio calls were handled in one location.

Since 1968, a very dedicated group of men and women dispatchers have worked tirelessly to create a safety conduit between park patrons and the Rangers who respond to their needs. They are rarely seen but always heard. Their voices are security blankets that provide a reassuring comfort to those in need of help before they can be relieved of what causes them harm.

Dispatchers are the unseen and rarely recognized heroes who are the story behind the badge. They are the foundation of every rescue, the lifeline to a fleeting life, and the omniscient presence that drives the very core of the Cleveland Metroparks Ranger Department.

On this date, we recognize this team and the service they, and all who have come before them, have provided to the citizens of Northeast Ohio, the visitors to the Park District, and the employees who provide this remarkable treasure we call – Cleveland Metroparks.

Captain Jack Hall was present and introduced dispatchers Meghan Thrasher, Mike Cannavino and Shelly Sudik as they were honored by all in attendance for the important work that they do each and every day.

#### c. Quarterly Grant Update

(Originating Sources: Donna L. Studniarz, Director of Strategic Initiatives/Jennifer McAnlis-Harvey, Grants Specialist/Kristen Trolio, Grant and Outreach Coordinator)

Cleveland Metroparks has received several grant awards in the third quarter of 2013; awards are as follows:

- \$50,000 in additional funds from private foundations for replacement of the NatureTracks vehicle, including \$30,000 from the Bruening Foundation, \$10,000 from the Hershey Foundation, and \$10,000 from the Abington Foundation (applications prepared by Kristen Trolio). To date, \$100,000 has been pledged, \$80,000 has been raised to meet the pledge, \$35,000 in requests are pending and \$115,000 in requests are in process.
- \$23,515 was awarded by the Sisters of Charity Foundation to expand the Youth Outdoors program in the central neighborhoods of Cleveland. (Application prepared by Kristen Trolio and John Rode.)
- \$23,500 has been granted for Cleveland Metroparks Economic Benefits Analysis through two grants: \$13,500 from the Cleveland Foundation and \$10,000 from The George Gund Foundation. The Economic Benefits Analysis study is being done by The Trust for Public Land. (Applications prepared by Jim Kastelic.)
- \$9,400 was granted for the Mirror Valley Headwaters Restoration through the U.
   S. Fish and Wildlife Service Partners for Fish and Wildlife program. (Application prepared by Constance E. Hausman.)
- \$7,500 was awarded by the S. K. Wellman Foundation to benefit the Cleveland Metroparks Trails Fund. (Application prepared by Karen Kannenberg.)
- \$5,000 was granted by the Dominion Foundation for installation of floating island wetlands at Rivergate Park. This grant was received in partnership with the Cuyahoga River Community Planning Organization (CRCPO). (Application prepared by Kristen Trolio and Jane Goodman of CRCPO.)
- \$2,500 was funded by the Dominion Foundation for "Putting Energy to Work Day", a corporate volunteer workday at Brookside Reservation. (Application prepared by Lisa Fellows.)

In the first three quarters of 2013, \$4,159,210 has been awarded in grants.

Kristen Trolio, Grant and Outreach Coordinator, was present and gave an overview of the grants received in 2013 thus far.

#### **INFORMATION/BRIEFING ITEMS/POLICY.**

d. Lake Erie Nature and Science Center Planetarium Upgrade Project
(Originating Sources: Richard Kerber, Chief Planning and Design Officer/Catherine
Timko, Executive Director, Lake Erie Nature and Science Center)

The Lake Erie Nature and Science Center maintains the only planetarium in western Cuyahoga County. The 30 foot diameter planetarium dome hosts programs for schools, summer camps, scout programs, public programs, preschool programs and soon, college level course work. The planetarium was constructed in 1968 and was attached to the main building in the 1995 expansion project. The 1,600 sf planetarium complex includes a 65 seat theater area, offices and a dark adaptation area for visitors preparing to enter the planetarium.

Current programming is provided using a Spitz optical mechanical "star ball" that projects stars and planets as points of light on the planetarium dome. Supplemental images for programs are presently provided by an array of individual projectors positioned around the dome. The "star ball" is in need of refurbishment and the projector system is outmoded by current technology for dome projection systems.

The Center has raised funds to undertake a complete renovation and updating of the planetarium facility. The "star ball" will be refurbished to be able to continue providing the traditional and highly accurate star maps. This is especially important to the college level classes and astronomy professionals. The "star ball" will be supplemented for public programming by a new digital "fish eye" projection system. This will allow many more special effects to be utilized for understanding the sky and the planets as well as larger depictions of the solar system and beyond.

The other major component of the planetarium, the dome, will be replaced as well. The old dome has warped over time creating gaps in the panels that make up its skin and the reflective finish is in poor condition. The new dome will be able to fully display the high resolution graphics of the new projection system.

Other improvements include replacement of the seating, floor covering, new lighting and sound systems and a dehumidification system to prolong the life of the new technology equipment.

The budget for the project is budgeted at \$750,000 including the technology equipment, installation and modifications to the building and building systems to accommodate the upgrades. Under Cleveland Metroparks guidance, the Center is in the process of negotiating a design build contract for the work with Parallel Partners, a design build firm formed through a joint venture of CPK Construction and Doty & Miller Architects. The same team successfully completed the renovation of the Wildlife Rehabilitation facilities at the Center last year. Contracts for the equipment will be finalized this month. Construction is anticipated to start in February and be complete in April of next year.

Catherine Timko, Executive Director of Lake Erie Nature and Science Center was present and thanked Cleveland Metroparks and the Board for its long-going relationship and support. Ms. Timko described the improvements that will take place in the Planetarium which will provide an incredible experience for its visitors.

#### e. Emerald Necklace Camp

(Originating Source: Chad Fifer, Education Specialist I, Cleveland Metroparks Zoo)

#### Background

Emerald Necklace Camp was offered in the summer of 2013 for campers ages 11-14 as a sampler camp for Cleveland Metroparks. The objective of the camp was to showcase the different types of activities offered throughout the Emerald Necklace and allowed campers to experience a little of what the different reservations have to offer. The camp was developed and offered as a joint program in coordination with Zoo Education, Outdoor Education, and Golf. The collaboration allowed campers to tour Cleveland Metroparks Zoo; explore the forest and creeks while hiking with a Naturalist at Bedford and Garfield Reservations; go pond dipping, insect netting, and waterfall hiking in South Chagrin Reservation; enjoy a golf lesson and tour the facilities at Seneca Golf Course; and participate in Voyageur Canoe, kayaking, and the Floating Water Lab at Hinckley Reservation.

Christine Korhnak, Education Manager of Cleveland Metroparks Zoo, and Valerie Fetzer, Nature Center Manager of Rocky River Nature Center, were present and updated the Board on this trial initiative. Commissioner Moore challenged staff to offer this camp to a larger number of individuals in the coming year.

# f. Cleveland Metroparks National Accreditation: Commission for Accreditation of Park and Recreation Agencies (CAPRA)

(Originating Sources: Brian M. Zimmerman, Chief Executive Officer/Donna Studniarz, Director of Strategic Initiatives)

In May 2012, Cleveland Metroparks began the process to become accredited through the National Recreation and Park Association (NRPA) Commission for Accreditation of Park and Recreation Agencies (CAPRA). This is the only national accreditation for park and recreation agencies by which agencies are recognized for excellence in operation and service. Accreditation is based on an agency's compliance with one hundred and forty-four (144) standards, including 36 "must-meet" fundamental standards. Staff throughout the agency worked together to update documents, procedures, and policies, prepare the 174 page CAPRA report, and provide over 1,000 supporting documents. In June 2013, the three-member NRPA CAPRA Visitation Team reviewed the prepared documentation, interviewed staff and toured park facilities. On October 7<sup>th</sup>, staff attended a Commission hearing at the 2013 NRPA Congress & Exposition in Houston, Texas to learn the results of the accreditation.


