#### Christine J. Korhnak, Education Manager

Christine Korhnak has served Cleveland Metroparks and Cleveland Metroparks Zoo for 31 years as an Education Assistant, Education Specialist, Senior Education Specialist, and Education Manager. Christine played a significant role in the Zoo Bus Program, African Elephant Crossing exhibit, the three-year community co-design project in partnership with Antioch University, assisting the Cleveland Zoological Society in grant and article writing, and the multi-year grant funded partnership with CMSD Rhodes

Additionally, she received many recognition awards including the AZA Exhibit Award for Significant Achievement for the Wolf Wilderness Exhibit, Community Service Award to Cleveland Metroparks Zoo Education Department from the Cleveland Municipal School District Office of Adult and Continuing Education, and AZA Service Award for Culture of Conservation Task Force which showcases her continued support, professionalism and high performance not only at Cleveland Metroparks, but in the greater community as well. ## (f) Establish Date of Hearing for Proposed 2025 Tax Budget

(Originating Source: Wade Steen, Chief Financial Officer)

Ohio Revised Code requires the Board of Park Commissioners to set the date for a public hearing for the proposed 2025 tax budget, and to advertise the same not less than ten days before the hearing date. The tax budget does not replace the appropriation document, approved by the Board by December 31st annually, but provides the Cuyahoga County Budget Commission with the assurance that all taxes levied by the Park District are needed for its operations and capital appropriations. The proposed tax budget will be distributed to the Board of Park Commissioners for approval at the meeting of June 20, 2024.

#### (g) Amendment to Management Services Agreement Re: Volleyball and Club Sports Operations – Lakefront Reservation (RFP #6588)

(Originating Sources: Brian M. Zimmerman, Chief Executive Officer/Joseph V. Roszak, Chief Operating Officer/Rosalina M. Fini, Chief Legal & Ethics Officer/Katie M. McVoy, Assistant Legal Counsel)

#### **Background**

On August 23, 2021, Cleveland Metroparks released Request for Proposal #6588 for Management Services for Volleyball and Club Sports Operations, which sought management services for volleyball at Whiskey Island and E. 55<sup>th</sup> and proposals for additional sports leagues at various locations throughout the Lakefront Reservation. The RFP indicated an operation term of three (3) years (January 1, 2022 through December 31, 2024) with an option to renew for up to three (3) additional years (through December 31, 2027).

Two proposals were received in response to RFP #6588—one from the then-current operator, Cleveland Plays, and one from Hermes Sports & Events ("Hermes"). Staff rated Hermes' proposal higher using the criteria set forth in the RFP and, pursuant to Board Resolution No. 21-11-160, the Board approved a three-year agreement for Hermes to operate volleyball and other club sports leagues from January 1, 2022 through December 31, 2024, with the option to extend the Agreement for up to three (3) additional years at the discretion of Cleveland Metroparks through December 31, 2027.

Since 2022, Hermes has successfully operated volleyball, kickball and touch football leagues at Whiskey Island, E. 55<sup>th</sup> and the Edgewater Overflow Lot. In both 2022 and 2023, Hermes exceeded its guaranteed minimum based on gross sales, paying Cleveland Metroparks a remittance of \$23,496.92 for 2022 operations (\$20,000 guaranteed minimum plus an additional \$3,496.92 based on gross revenue) and \$33,421.93 for 2023 operations (\$20,000 guaranteed minimum plus an additional \$13,421.93 based on gross revenue).

Hermes is interested in continuing its operations for the next three years and has offered the following financial incentives for the years 2025-2027:

The total compensation includes \$5,000 more in capital investments than 2022-2024 and will result in additional compensation to Cleveland Metroparks if Hermes' Gross Sales exceed \$87,000 in any calendar year.

Based on Hermes' success over the last three years and its increased compensation offer, staff recommends extending the agreement with Hermes through and including December 31, 2027.

# (h) Authorization to Initiate Litigation to Recover Damages for Destruction of Heritage Park Docks

(Originating Sources: Brian M. Zimmerman, Chief Executive Officer/Sean E. McDermott, Chief Planning & Design Officer/Rosalina M. Fini, Chief Legal & Ethics Officer/Kyle G. Baker, Senior Assistant Legal Counsel and Director of Real Estate/Alexis E. Triozzi, Staff Attorney)

#### **Background**

On August 23, 2023, a vessel known as the M/V American Courage, owned by Rand Logistics, Inc. ("Rand Logistics"), struck and severely damaged newly installed docks (the "Docks") owned by the Cleveland Metropolitan Park District ("Cleveland Metroparks") located at Heritage Park in Cleveland, Ohio.

Since the August 23 incident, Cleveland Metroparks staff attempted to work with Rand Logistics to reasonably resolve this matter. After a site visit to inspect damages on October 9, 2023, Cleveland Metroparks' contractor prepared an initial cost estimate of \$557,977.28 to repair the damage to the Docks. Rand Logistics refuted this cost estimate and Cleveland Metroparks continued to work with its contractor and representatives of Rand Logistics to develop a revised plan for repairs and to bring this initial cost estimate down to a revised cost estimate of \$397,967.34. Rand Logistics was not responsive to the revised cost estimate provided by Cleveland Metroparks. On March 13, 2024, Cleveland Metroparks sent a letter to Rand Logistics demanding a response to the revised cost estimate. In response, Rand Logistics sent a letter dated March 19, 2024 offering to pay \$250,000.00 in repair costs to resolve the matter - \$147,967.34 less than Cleveland Metroparks' already reduced cost estimate of \$397,967.34. Cleveland Metroparks staff asked Rand Logistics to provide evidence to support Rand Logistics' cost estimate. Rand Logistics was not able to provide satisfactory evidence to support its cost estimate.

Rand Logistics has demonstrated that it is unwilling to negotiate in good faith with Cleveland Metroparks staff to reasonably resolve this issue and pay for the damage it caused to the Docks. The delay in resolving this matter has further resulted in Cleveland Metroparks inability to use the Docks for the 2024 season, causing further financial loss to Cleveland Metroparks.

(i) Authorization of Land Acquisition and Clean Ohio Conservation Fund Grant Application: EBMHC, LLC Property (± 28.5 acres) – Euclid Creek Reservation (Originating Sources: Brian M. Zimmerman, Chief Executive Officer/Natalie Ronayne, Chief Development Officer/Kristen Trolio, Director of Grants/Rosalina M. Fini, Chief Legal and Ethics Officer/Kyle G. Baker, Senior Assistant Legal Counsel & Director of Real Estate/Alexis Triozzi, Staff Attorney/Stephanie Kutsko, Sr. Real Estate Manager)

Western Reserve Land Conservancy ("WRLC"), through a subsidiary named EBMHC, LLC ("EBMHC") (collectively "WRLC Parties"), acquired a ± 28.5-acre lakefront property on Lakeshore Boulevard in the City of Cleveland ("WRLC Property") (reference map, page 101116). This is one of the few remaining lakefront parcels of its size in the City of Cleveland and is nearly fully surrounded by Cleveland Metroparks Euclid Creek Reservation. The WRLC Property includes the Euclid Beach Mobile Home Park, which is in the process of being vacated. Acquisition of the WRLC Property would contribute to Cleveland Metroparks goal of protecting our regions lakefront and allow Cleveland Metroparks to protect, restore, and manage the WRLC Property to expand upon the lakefront portion of Euclid Creek Reservation, creating more opportunities for access to and exploration of the shores of Lake Erie.

Cleveland Metroparks staff collaborated with the WRLC Parties after the WRLC Parties made the decision to acquire this  $\pm$  28.5-acre property. During the collaboration, Cleveland Metroparks strongly encouraged the WRLC Parties to follow the Federal Uniform Relocation Assistance and Real Property Acquisition Policies Act ("URA") with regard to any eligible household that was residing on the WRLC Property to ensure a fair and equitable relocation of the residents of the Euclid Beach Mobile Home Park. EBMHC is currently shepherding the URA process and is prepared to provide Cleveland Metroparks with a certification that the URA has been followed. Cleveland Metroparks and WRLC have productively collaborated in the past, including, but not limited to, the 2017 acquisition of a 102-acre property and the 2020 acquisition of a 48-acre property, both adjacent to Cleveland Metroparks Brecksville Reservation. As part of this proposed collaboration, Cleveland Metroparks, EBMHC, and WRLC will enter into a purchase agreement whereby, contingent upon the award of funds from the Clean Ohio Conservation Fund ("Clean Ohio"), EBMHC following the URA process (and certifying the same to Cleveland Metroparks), EBMHC removal of all of the manufactured/mobile homes, and ensuring all residents have been appropriately and fairly relocated, EBMHC will transfer fee simple title to the WRLC Property to Cleveland Metroparks for a purchase price of \$5,800,000. Cleveland Metroparks plans to apply to Clean Ohio to acquire the WRLC Property as outlined below with WRLC providing \$800,000 towards the purchase price.

#### **Funding**

Clean Ohio, administered by the Ohio Public Works Commission, provides funds for acquisition of greenspace in order to conserve natural areas and protect the state's natural resources. Cleveland Metroparks proposes to apply to Clean Ohio for funding to acquire the WRLC Property. Automatic Data Processing ("ADP") has served as the Human Resources Information System ("HRIS") for Cleveland Metroparks since 2006. ADP has processed Cleveland Metroparks payroll since 1990.

Cleveland Metroparks is currently operating ADP HRIS and payroll processing under an agreement ("the Guaranteed Thirty-Six Month Price Agreement") effective July 1, 2012 (Board Resolution No. 12-06-121), as amended multiple times (Board Resolution Nos. 14-01-023, 17-12-188, and 21-05-065).

On September 21, 2023, the Board approved a new agreement with ADP for Human Capital Management ("HCM") solutions, which has an expected start date of later this year (Board Resolution No. 23-09-149). The Thirty-Six Month Price Agreement is set to expire on May 20, 2024, before the new contract goes into effect.

Until the anticipated go-live of the ADP Next Gen HCM platform in December 2024, ADP has agreed to a ninth (9<sup>th</sup>) amendment that includes month-to-month service with no increase in fees.
