# MINUTES OF THE BOARD OF PARK COMMISSIONERS OF THE CLEVELAND METROPOLITAN PARK DISTRICT

### JULY 9, 2015

The Board of Park Commissioners met on this date, Thursday, July 9, 2015 8:00 a.m., at the Board's office, 4101 Fulton Parkway, Cleveland, Ohio.

The roll call showed President Dan T. Moore, Vice President Debra K. Berry, and Vice President Bruce G. Rinker, to be present. It was determined there was a quorum. Chief Executive Officer, Brian M. Zimmerman, Chief Financial Officer, David J. Kuntz, and Chief Legal and Ethics Officer, Rosalina M. Fini, were also in attendance.

#### **APPROVAL OF MINUTES.**

**No. 15-07-111:** It was moved by Vice President Berry, seconded by President Moore and carried, to approve the minutes from the Regular Meeting of June 18, 2015, which were previously submitted to the members of the Board, and by them read.

#### (a) Swearing in of Rangers

#### Stephen M. Howard

Steve is currently a part-time officer for the City of Wakeman, and works full time at University Hospitals Elyria Medical Center as a Protective Services Officer. Steve graduated in 2006 from Baldwin-Wallace College with a major in Philosophy and a concentration in Spanish, and also graduated from Lorain County Community College's Basic Police Academy in June 2012.

#### Megan J. McNulty

Megan is a May 2014 graduate of the Polaris Natural Resources Ranger Academy. That same month she was sworn in as a reserve officer in Wakeman, Ohio. In June 2014, she was sworn in as a part-time officer in Wellington, Ohio as their first female officer. Megan has an Associate of Applied Science Degree from Lorain Community College, graduating in May 2012.

#### Krystina M. Schneider

Krystina is a 2011 Kent State Police Academy graduate. She is currently attending Lakeland Community College and will graduate with a major in Criminal Justice and an Associate in Applied Science. Krystina is a park ranger for the Summit County Metro Parks.

#### Tyler M. Tomasheski

Tyler graduated in 2012 from Hocking College with an Associate in Applied Science in Natural Resources Law Enforcement. He graduated from the National Ranger Training Institute (OPOTA) in January 2014.

(b) Depository of Public Funds for a Five Year Period, July 2015-2020 (Originating Source: David J. Kuntz, Chief Financial Officer)

#### **Background**

Cleveland Metroparks, for a five-year period (July 2015 to July 2020), must select a bank depository, said selection based on advertised Request for Proposal. A recap of the Request for Proposals received for Cleveland Metroparks depository contracts follows. Current active depository services (July 2010 to July 2015) are provided by PNC Bank.

#### A. Banks for Deposit of Active Funds

#### **Basic Banking Services**

The following banks offered applications for deposit of active funds with Cleveland Metroparks: PNC Bank, Fifth Third Bank, Huntington Bank, US Bank, and First Merit Bank. The proposals are summarized as follows:

(1) The proposal for banking services is based upon a list of common banking services at historical average volumes. Volume increases during summer months will result in a monthly fee that is higher than the average used in the proposal. Also, there are additional banking services that are priced differently from bank to bank.

The 2014 actual annual cost for banking services with PNC Bank was a net of \$41,058 received. PNC Bank is being recommended as Cleveland Metroparks primary depositor, with a depository contract based on their best proposal for the five year period.

Based upon estimated volumes, the new agreement for active funds with PNC Bank will generate \$62,314 in revenue to Cleveland Metroparks annually or \$331,569 over the new five year term, including a one time renewal incentive of \$20,000.

US Bank is being recommended as Cleveland Metroparks secondary depositor, with a depository contract based on their next best proposal. The US Bank depository contract will only be utilized in the event of PNC Bank's non-performance.

#### Merchant Services (Credit Card and Gift Card Processing)

The following companies offered applications for merchant services with Cleveland Metroparks: PNC Bank, Fifth Third Bank. Huntington Bank, US Bank, First Merit Bank and Leverich Contracting Services, LLC. The proposals are summarized as follows:

(1) The proposal for merchant services is based upon an "Interchange Plus" pricing structure. The fees indicated by the proposers are in addition to standard rates charged by Visa, Mastercard, and Discover.

(2) The annual costs were calculated based on estimated 255,000 transaction count and \$8,200,000 in credit card sales.

(3) The total annual fee for Gift Cards assumes 7,500 transactions annually.

US Bank is the current provider of merchant services for Cleveland Metroparks. The US Bank proposal represents a decrease in the per transaction fee from their previous agreement. US Bank is being recommended as Cleveland Metroparks primary credit card processor based on their lowest and best proposal for the five year period.

Fifth Third Bank is being recommended as Cleveland Metroparks secondary credit card processor based on their next lowest proposal. The Fifth Third Bank contract will only be utilized in the event of US Bank's non-performance.

#### B. <u>Banks for Deposit of Interim Funds</u>

The chart below lists the banks to be approved for investment of interim funds. This is the major investment vehicle for Cleveland Metroparks. Banks listed will be contacted for investment quotations as cash is available for investment purposes. The collateralized amount represents the total amount of investment that they are willing to undertake at any one time during the year. Collateralization is accomplished through treasury bills, other governmental agencies or an investment bond at the face value of the amount of the investment. Cleveland Metroparks investments are defined by statute and are found in the District's Investment Policy. Primarily, they represent certificates of deposit, treasury bills and bills or notes from other governmental agencies guaranteed by the full faith of the Federal Government.

No. 15-07-113: It was moved by Vice President Rinker, seconded by Vice President Berry and carried, that PNC Bank be named as Cleveland Metroparks primary depository for active funds, for the period of July 18, 2015 - July 17, 2020; further, that US Bank be named as Cleveland Metroparks secondary depository for active funds, for the period of July 18, 2015 - July 17, 2020; further, that US Bank be named as Cleveland Metroparks primary credit card processor for the period of July 18, 2015 - July 17, 2020; further, that Fifth Third Bank be named as Cleveland Metroparks secondary credit card processor for the period of July 18, 2015 - July 17, 2020; further, that PNC Bank, Fifth Third Bank, Huntington Bank, US Bank, First Merit Bank and Key Bank be approved for the deposit of interim funds for the same period of time, at the collateralized amounts shown: further that the Board authorize the Chief Financial Officer to execute depository contracts and related documents, in form acceptable to the Chief Legal and Ethics Officer, on terms described above.

(c) House at 35069 Cannon Road, Bentleyville, Ohio – South Chagrin Reservation (Originating Sources: Brian M. Zimmerman, Chief Executive Officer; Joseph V. Roszak, Chief Operating Officer; Rosalina M. Fini, Chief Legal & Ethics Officer; Nancy Desmond, Director of Special Projects)

#### **Background**

On May 7, 2015, the Board of Park Commissioners of the Cleveland Metropolitan Park District (Board) considered the matter of the McFarland House located at 35069 Cannon Road which the Village of Bentleyville (Village) and the Friends of the McFarland Homestead (Friends) have struggled with restoration efforts over the past seventeen years. Based upon the Village's and the Friend's failure to make more progress on restoration and as a result of concerning safety issues, the Board authorized the relocation of the McFarland House by June 6, 2015 or its demolition.

After fruitful discussions between Cleveland Metroparks Chief Executive Officer Brian M. Zimmerman and Mayor Leonard Spremulli, an agreement was negotiated to allow additional time for the Friends and Village to engage in a relocation feasibility study, fundraising efforts, and the relocation of the McFarland Home.

# **No. 15-07-114:** It was moved by Vice President Rinker, seconded by Vice President Berry and carried, to authorize the Chief Executive Officer (CEO) to authorize and execute any documents or agreements with the Village which contain the following terms:

1. The Village of Bentleyville shall:

a. Conduct a feasibility study to relocate the McFarland Home which shall be completed within six (6) months of the date of this resolution; and,

b. Raise funds to relocate the McFarland Home to be completed within one (1) year of this resolution; and,

c. If deemed feasible, relocate the McFarland Home within one (1) year of this resolution.

2. The CEO will allocate the funds that would have been spent on the abatement and demolition to be used toward the relocation of the McFarland Home, if relocation is deemed feasible by the study; and,

3. If the feasibility study is not conducted and/or completed by the six month deadline or if the feasibility study concludes that relocating the McFarland Home is not feasible, Cleveland Metroparks may move forward with abatement and demolition at that time.

(d) Big Creek Reservation Land Acquisition: Lake to Lake Trail (±2.5 acres) (Originating Sources: Brian M. Zimmerman, Chief Executive Officer/Donna L. Studniarz, Chief of Strategic Initiatives/Stephanie Kutsko, Land Protection Coordinator)

Adjacent and visible from the 2.5 mile Lake to Lake Trail is the Meincke property, a  $\pm 2.5$  acre property located north of the Lake Isaac Waterfowl Sanctuary and just south of the Fowles Wetland area (reference map, page **79981**). The Lake-to-Lake area of Big Creek Reservation is a highlight of the reservation, providing a universally accessible all-purpose multi-use trail that travels through 175 acres of headwater wetlands and connects two glacial kettle lakes, Lake Abram and Lake Isaac. Cleveland Metroparks acquired a  $\pm 0.5$  acre conservation easement from Duane and Roberta Meincke in 2003 for the construction of the Lake-to-Lake trail.

Cleveland Metroparks has the opportunity to acquire the entire property in fee simple title as Karl Meincke, Executor of the estate of Roberta J. Meincke, desires to sell the property. The property contains a residence which was built in 1858, a garage, barn and small shed, which, if the property was acquired, would be demolished and restored to a natural condition. The heirs have agreed to sell the property via fee simple title for \$170,000. The acquisition will provide a buffer to this highly popular trail and continued protection of the natural resources in a significant natural area of Big Creek Reservation.

#### No. 15-07-115:

It was moved by Vice President Rinker, seconded by Vice President Berry and carried, to authorize the acquisition of fee simple title of  $\pm 2.5$  acres as hereinabove described, through the estate of Roberta J. Meincke, Karl Meincke, Executor, for a purchase price of \$170,000, subject to the approval of the environmental assessment report and evidence of title, including exceptions to title, by the Chief Legal and Ethics Officer; further, that the Board authorize the Chief Executive Officer to execute agreements, together with supplemental instruments related thereon, if any, as deemed necessary or appropriate and in form acceptable to the Chief Legal and Ethics Officer.

(e) Adoption of Revised Cleveland Metroparks Codified Rules and Regulations - 2015 (Originating Sources: Daniel J. Veloski, Chief Ranger/Rosalina M. Fini, Chief Legal & Ethics Officer/Anne Eisenhower, Chief Prosecuting Attorney)

#### **Background**

There is a need to amend the Park District's Codified Rules and Regulations to ensure conformity with the Ohio Revised Code and other policy decisions. In this review, the following modifications are hereby proposed:

 <u>General Required Changes</u>: Several changes occurred to the Ohio Revised Code and Bylaw changes require the Board of Park Commissioners to further update its Codified Rules and Regulations as recommended by the Walter H. Drane Company, who performed the previous comprehensive code revisions for Cleveland Metroparks. A Table of Contents of Park District Rules and Regulations, with modifications, is provided on pages <u>79982</u> to <u>79983</u>.

#### 2. Specific Changes to Regulations:

- a. Recreation.
  - 1) 543.02 (a) Swimming and <u>wading are</u> is hereby permitted except at areas that are otherwise designated. Users assume all risk of any body contact or other use of the water.
  - 2) 543.03 (a) <u>Unlicensed Watercraft and Motor Boats Prohibited.</u> No watercraft driven or propelled by motors shall be operated upon any lakes, rivers, ponds or other bodies of water owned by, or under the control of the Board, except Rocky River in Scenic Park in the Rocky River Reservation for access to Lake Erie, and Hinckley Lake in the Hinckley Reservation, the Cuyahoga River and Lake Erie adjacent to Cleveland Metroparks. Watercraft operated on Hinckley Lake shall be operated only with electric motors, <u>unless the watercraft is rented from Cleveland Metroparks</u>, and operation of all watercraft shall be at a speed not to exceed six (6) miles per hour. No person shall use rafts, tubes, flotation devices and or other objects supporting persons which are not licensed by the State of Ohio and such are hereby prohibited. Sailboards are permitted, if the operator wears a type 1, 2 or 3 personal flotation device.

#### b. **Refine restrictions on pets.**

1. 505.01(a) No unauthorized person shall bring into, permit, have, or keep in any part of the park any household pet, other animal destructive to birds or other animals except that dogs or cats are permitted (other than in designated swimming areas or adjacent beaches <u>as determined by the Chief Executive Officer or his designee</u>) if they have a valid registration tag (except for guide dogs registered under Ohio R.C. 955.011) and are controlled at all times on a leash or tether not more than eight feet long.

(2) to walk through water, snow, sand, or any
other substance that impedes free motion

or offers resistance to movement.

2. Non-passenger motor-powered and remote control devices

**509.05** (a) Engine-powered miniature model rocket or rocket-type device and toy radio controlled airplanes, boats, cars, sirens or other noisemaking devices shall not be operated, except in designated areas. "Motor-powered" or "remotecontrolled" rockets, rocket-type devices, model airplanes, drones, boats, cars, or other similar devices, weighing less than fifty-five pounds, shall not be operated throughout the Park District, except in designated areas, or by permit. In those designated areas or by permit, any and all applicable Federal and State regulations must be strictly followed. (b) "Ignition-powered" rockets, rocket-type devices, model airplanes, drones, boats, cars, or other similar devices and motor-powered or remote controlled rockets, rocket-type devices, model airplanes, drones, boats, cars, or other similar devices, weighing more than five pounds are prohibited throughout the Park District. (c) Whoever violates this section shall be fined not more than one hundred fifty dollars (\$150.00) for

the first offense and not more than one thousand dollars (\$1,000) for each subsequent offense. (ORC 1545.99)

#### **CONSTRUCTION CHANGE ORDERS (07/09/15)**

Pursuant to Cleveland Metroparks By-Laws, Article 5 (Procurement), Section 4 (b)and (c), as revised and approved by the Board of Park Commissioners on January 10, 2013, "...the CEO is not authorized to enter into any change orders to construction contracts, without prior approval of the Board in each instance, except that the CEO is authorized to enter into change orders to construction contracts, without prior approval of the Board in each instance, where the additional cost is less than THE LESSER OF: (i) \$50,000, or (ii) ten percent (10%) of the cost of the contract. Each change order by the CEO under this Article shall be reported to the Board at the next meeting of the Board following the execution of said change order."

(c). "Amendment to Professional Service Contract. #### b. Cleveland Metroparks Reservations: Walk – Bike Shed Analysis

(Originating Sources: Donna L. Studniarz, Chief of Strategic Initiatives/Sara Meier Byrnes, Senior Strategic Park Planner/Tom Kraft, Planning Technician)

As part of long-range and strategic planning activities, staff has analyzed public access to each of the 18 Cleveland Metroparks reservations and Cleveland Metroparks Zoo to determine the total populations and their characteristics within a half-mile walk and a 3 mile bike ride of each park area. The analysis utilized existing park access points and considered the walkability and bike-ability to the park via sidewalk and roadway networks within the adjoining communities. The analysis provides information on the local populations that each reservations likely impacts that can guide decision making on future trail connectors, facility uses, and programming. Staff will discuss the methodology and results of the analysis.

#### c. Garfield Park Center Changes Over Time

(Originating Sources: Joseph V. Roszak, Chief Operating Officer/ Wendy Weirich, Director of Outdoor Experiences)

Since its origin in 1987, Garfield Park Nature Center has been through many changes. After acquiring Garfield Park Reservation in 1986, it was only natural for Cleveland Metroparks to consider adding to our collection of education centers. This education center was the first center outside of the original three (Rocky River, Brecksville and North Chagrin) for decades. Adding an education center in the center of our Emerald Necklace made sense. Since then we have added two more education facilities in our core. Garfield is adapting to the times with some new initiatives that help Cleveland Metroparks serve the community even better.



Section 1. The rules and regulations of the Cleveland Metropolitan Park District which will be published are hereby revised and approved. One copy of the Codified Rules and Regulations shall be certified as correct by the President of this Board and the Chief Executive Officer of the Cleveland Metropolitan Park District, attached to this resolution as a part hereof, and filed with the permanent resolutions of this Board. All provisions of the Codified Rules and Regulations continue in full force and effect, including such revisions, commencing on and after 12:01 a.m. Eastern Standard Time on August 8, 2015.

Section 2. The Chief Executive Officer of this Board is hereby authorized and directed, in the manner and as provided in Section 731.23, Ohio Revised Code, to cause to be published in the manner required by that Section the revised provisions contained in the Codified Rules and Regulations and to give notice of the approval, adoption and enactment of the changes to the Codified Rules and Regulations except that such publication shall be made in The Cleveland *Plain Dealer* and the *Medina Gazette*.

Section 3. This Board finds and determines that all formal actions of the Board concerning and relating to the adoption of the changes to regulations were taken in an open meeting of this Board and that all deliberations of this Board and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

Section 4. This resolution shall be effective immediately upon its adoption by this Board, provided that the Codified Rules and Regulations revised by this resolution shall become and be effective from and after 12:01 a.m. Eastern Standard Time on August 8, 2015.
